

NAKA-KON 2019 SWEEPSTAKES

OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

Registration to Naka-Kon 2019, held at the Overland Park Convention Center, March 15-17, 2019 (the “Event”), constitutes full and unconditional agreement to and acceptance of these Official Rules.

Eligibility: Naka-Kon 2019 Sweepstakes (the “Sweepstakes”), sponsored by NAKA-KON JAPANESE CULTURAL EDUCATION ASSOCIATION and RIGHT STUF ANIME (the “Sponsor”), is open to all registrants of the Event who are legal residents of the 50 United States and the District of Columbia who are age 18 or older or between the age of 14 and 18 with parental consent at the time of registration, EXCEPT: (1) employees, officers, and directors of NAKA-KON JAPANESE CULTURAL EDUCATION ASSOCIATION (including immediate family members and members of the same household), (2) any sponsor of the Event or provider of prizes offered in the Sweepstakes, and (3) individuals who do not have current access to an internet connection in order to register for the Event.

Registration Period: 12:00:00am August 3, 2018 and end at 11:59:00pm March 1, 2019.

How to Enter – Online Registration: All who register for the Event by completing the online registration at <https://naka-kon.com/registration> during the Registration Period are *automatically* entered to win.

How to Win, Notification, and Verification: Potential winners will be selected by random drawings and announced during the Event. Odds of winning depend on the number of registrants. Prizes will be mailed to winner.

Prizes: All prize details are at the Sponsor’s sole discretion. Prizes are awarded “as is.” Prizes are not transferable or redeemable for cash. No substitutions of prizes by winners are allowed, but Sponsor reserves the right to substitute a prize of equal or greater value at its sole discretion.

General Conditions: By entering this Sweepstakes and/or accepting any prize, registrants agree: (1) to release, discharge, and hold harmless the NAKA-KON JAPANESE CULTURAL EDUCATION ASSOCIATION, RIGHT STUF ANIME, and its shareholders, officers, directors, employees, members, agents and assigns (collectively, the “Released Parties”) from liability of any kind or nature for any loss, claims, damages, or injuries of any kind resulting in whole or in part, directly or indirectly from entrant’s participation in this Sweepstakes or from the acceptance and use/misuse of any prize; and (2) to abide by, and be bound by these Official Rules and the decisions of the Sponsor relating to participation in the Sweepstakes, selection of winners and awarding of prizes, which shall be final. Acceptance of any prize constitutes permission to use winner’s name, biographical information, city and state of residence, voice, photograph, image and/or likeness for advertising, promotional and other purposes in any and all media now known or hereafter devised, worldwide, in perpetuity, without further compensation, notification or permission from entrant or any third party and without prior

notice, approval or inspection, and to execute specific consent to such use if asked to do so, unless prohibited by law. Released Parties are not responsible for lost, interrupted or unavailable network, server, Internet Service Provider (ISP), website, or other connections, availability or accessibility or miscommunications or failed computer, satellite, telephone or cable transmissions, lines, or technical failure or jumbled, scrambled, delayed, or misdirected transmissions or computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of entries, the announcement of the prize[s], or in any Sweepstakes-related materials. Released Parties are also not responsible for any incorrect or inaccurate information, whether caused by site users, tampering, hacking, or by any equipment or programming associated with or utilized in the Sweepstakes. Released Parties are not responsible for injury or damage to any person's computer related to or resulting from participating in this Sweepstakes or downloading materials from or use of the website. Persons who tamper with or abuse any aspect of the Sweepstakes or website, who act in an unsportsmanlike or disruptive manner or who are in violation of these Official Rules, as solely determined by Sponsor, will be disqualified and all associated entries will be void. Should any portion of the Sweepstakes be, in Sponsor's sole opinion, compromised by virus, worms, bugs, non-authorized human intervention or other causes which, in the sole opinion of the Sponsor, corrupt or impair the administration, security, fairness or proper play, or registration to the Event, or should the Sweepstakes be unable to run as planned for any other reason, Sponsor reserves the right at its sole discretion to suspend, modify or terminate the Sweepstakes and, if terminated, at its discretion, select the potential winner[s] in a random drawing from among all eligible, non-suspect registrants. CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE THE WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE IN VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES AND OTHER REMEDIES (INCLUDING ATTORNEYS' FEES) FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT OF THE LAW, INCLUDING CRIMINAL PROSECUTION.

Forum Selection: The Sweepstakes shall be governed by the laws of the State of Kansas. Each registrant of the Event knowingly and voluntarily intends and agreed that (1) the mandatory venue for any action in any way related to or arising out of the 2019 Sweepstakes or prizes awarded shall be resolved individually without resort to any form of class action and shall be the state and federal courts in and for Johnson County, Kansas; and (2) any and all claims, judgments, and awards shall be limited to out-of-pocket costs incurred, including costs associated with entering the Sweepstakes, but in no event attorneys' fees. Each registrant hereby knowingly and voluntarily waives any and all objections to venue and personal jurisdiction in the foregoing, and submit themselves thereto. Each registrant hereby waives any right such registrant may have to assert the doctrine of forum non conveniens or similar doctrine or to object to venue with respect to any proceeding brought in accordance with this paragraph, and stipulates that the aforementioned courts shall have in personam jurisdiction and venue over them for the purpose of litigating any dispute, controversy, or proceeding arising out of or related to the Sweepstakes.
